
Counseling Updates:

Guest Speaker:

Phasasha Pharr: Financial Aid

The Covid Withdraw form is an internal form for financial aid. Students do not really know about the form. Students who withdrew from courses due to COVID-19 related emergency issues are eligible for relief from certain financial aid requirements. The form waives EWs for Spring 2020-Spring 2023 so these do not go against a student for SAP purposes (the units for those semesters do not count). There is no limit to the number of units that can be waived. Documentation is needed to be included with form. See attached form.

The deadline to apply for free classes for FA23-SP24 is the end of the school year (June 30).

SAP Appeal:

4-6 weeks is the processing time for appeals

Students with 90 plus units need CSEP.

To follow up on: Request to have the appeal forms be distributed/available after the third week of each new semester. Co-chairs will meet with financial aid to have better practice for the upcoming school year regarding appeal forms-for now follow the same process.
